#### Benesch Establishes Fund in Memory of Our Friend and Partner, Howard Levy

Howard Levy served as a partner at Benesch for over 25 years, was Chair of the Labor & Employment Practice Group for over 20 years and served as

the firm's first General Counsel.

Howard despised prejudice and discrimination of any form, and became involved with the Anti-Defamation League as an avenue to fight discrimination in society. The ADL was founded in 1913. As "the nation's premier civil rights/human relations agency, ADL fights anti-Semitism and all forms of bigotry, defends democratic ideals and protects civil rights for all."

In addition to serving as Chairman of the ADL's Regional Office (covering the entire states of Ohio, Kentucky and West Virginia and the western half of Pennsylvania), Howard sat on its National Board. He also led the Regional Office of the ADL's Summer Associate Research Program, which encourages law students to research current human and civil rights issues related to the ADL's mission. The Program provides the ADL with valuable information and tools and teaches students the importance of pro bono legal work.

After Howard's passing in September 2007, Benesch wanted to continue to honor his memory, contributions to the ADL and dedication to the Greater Cleveland community in a meaningful and lasting way. The firm contributed a generous and long-term donation toward the establishment of the Howard A. Levy Memorial Fund of the ADL to support our region's Summer Associate Research Program. The fund will enable the ADL to hire a capable summer intern each year, who will help coordinate the Research Program and provide valuable office assistance to the ADL staff.

"Howard was our friend and partner for more than 25 years," said Ira Kaplan, Benesch's Managing Partner. "The ADL and its mission were very important to him. We are honored to provide the resources to fund this program that bears our dear friend's name."

Technical Consumer Products, Inc. (TCP) is the home of lighting innovation. As the world leader in energy-efficient lighting, no one makes more compact fluorescent lamps (CFLs) than TCP. The company manufactures a majority of the CFLs sold in the U.S. Its product line also includes cold cathode, linear and high bay systems, exit and emergency lighting, HID, energy-efficient fixtures and LED lighting products.

TCP's business focuses on the importance of energy conservation. In order to educate consumers, TCP works with businesses and trade publications and sponsors a number of industry-leading events to promote the benefits of energy-efficient lighting and the products and services available on the market. The company has also created a nationwide educational program for school-age children designed to teach them the importance of conserving


energy, even if it is "just one bulb at a time." Additionally, the children are able to take part in selling CFLs as a fund-raising opportunity.

Ellis Yan, founder and CEO of TCP, immigrated to Cleveland from Shanghai at age 23, earned an accounting degree from Cleveland State University and began to pursue his interest in energy-efficient lighting. He built TCP from the ground up through debt and working capital. Yan now owns three plants in China that generate about 1.4 million CFLs per day. The company's Aurora, Ohio, headquarters houses its executive offices, a warehouse, laboratories and manufacturing facilities for special-order fixtures.

Managing a rapidly growing international business also means managing the many legal issues that arise as a result of new technology and changes in legislation. Since 2002, Benesch has served as legal counsel to TCP, advising Yan and his team in areas including intellectual property, real estate and public affairs. "Benesch was with us when we learned to crawl, walk and now they're running right along with us," Yan says.

The team of Benesch attorneys who work daily with TCP has grown to know the company's business well. When President Bush signed a new energy bill this past winter, TCP's market and industry were dramatically affected. Benesch helped TCP craft its responses to the legislation and eased the company through the related transitions.

# waiting Childfund

Ryan Hooper, a senior associate in the Health Care Practice Group, recently handled a pro bono representation of Waiting Child Fund (WCF), a Cleveland charity that coordinates funding for adoptions of children with special needs.

WCF's goal is to fund the efforts to place children who have been waiting the longest and are most at risk of "aging out" of the system. The organization works directly in conjunction with private and public agencies that have the skills and resources to find permanent families for children in need. WCF raises money to build partnerships and enable collaborations between agencies to make successful adoptive placements.

Ryan was able to assist WCF by reviewing a county request for proposals and advising on a major funding agreement for the organization. WCF's request for assistance was made via Business Volunteers Unlimited (BVU), a local organization dedicated to strengthening non-profits through general assistance and board placement. Ryan previously participated in the non-profit board training and placement program conducted by BVU, which resulted in his election to the board of trustees of Neighborhood Family Practice, a Federally Qualified Health Center on the Near West Side.

In addition to the support of Ryan Hooper, WCF is also supported by **Jessica Angney**, an associate in Benesch's Tax Practice Group. Jessica was recently elected as a member of WCF's Board of Trustees. She looks forward to furthering the mission of finding adoptive families for school-age children with special needs.

Brad Sandler.




