Windy City Shuffle: Crowell & Moring, Benesch, Ballard Spahr

Law360 (April 22, 2022, 4:44 PM EDT) -- In Law360's occasional roundup of Chicago lawyers' latest moves, Crowell & Moring has hired a brand protection litigator, Benesch has promoted and added new partners in the intellectual property and corporate spaces, and Ballard Spahr has nabbed a patent litigator.
