

## Benesch, 'Bullish' On Growth, Names Its Largest Partner Class

Law360 (January 5, 2023, 3:11 PM EST) -- Benesch Friedlander Coplan & Aronoff has announced the largest partner class in its 85-year history, its managing partner told Law360 Pulse on Thursday, with 20 new partners named across core practice areas and in offices in Ohio, Illinois and Delaware.

Benesch's managing partner, Gregg Eisenberg, said the firm was "bullish" on continued growth in 2023 despite economic conditions. Of Benesch's new partner class, 15 are lateral hires and five are "homegrown" talent, Eisenberg said.

"These attorneys have demonstrated outstanding leadership and commitment to our clients during their tenure with the firm," Eisenberg said in the announcement. "They have made remarkable contributions to our growth and remain committed to our long-standing culture of client service. We are excited to welcome them to the partnership and look forward to their continuing contributions to Benesch's success."

Eisenberg told Law360 Pulse that the new partners made up a "special and talented class" that was the largest in the firm's history. Benesch is celebrating its 85th anniversary this year.

"Nine of the 20 are diverse, which I also think is special," Eisenberg said. The new partner class is diverse not only in its racial and gender makeup, but also in its "skill set," he said.

Eisenberg told Law360 Pulse that Benesch continued to grow, having nearly doubled in size over the last six years or so. The firm, which was founded in Cleveland in 1938, now has eight offices, according to its website. In addition to its Cleveland, Chicago, Columbus and Wilmington offices, Benesch has offices in Hackensack, New Jersey; New York City; San Francisco; and Shanghai.

The roughly 345-attorney firm hired 54 attorneys in 2022, with all of those hires retained headed into 2023, a firm representative told Law360 Pulse.

"While we've grown, we think we have some of the highest retention rates as well," Eisenberg told Law360 Pulse.

Eisenberg said the firm was "very bullish" on its future, and in "a comfortable place" to be able to weather economic times and continue to grow in 2023.

Benesch kicked off 2022 with 13 new partners.
