- Take I-71 North to I-90 East
- Exit at East Ninth Street
- Take East Ninth Street past Progressive Field and cross Euclid and Superior Avenues.
- One Cleveland Center is on the right, and the garage entrances are on Rockwell Avenue (immediately before the building) and St. Clair Avenue (immediately after the building). Additional parking is available at The Galleria at Erieview and the Cathedral Plaza Parking Garage (across from garage entrance on Rockwell).

From the East

- Take I-90 West
- Exit at East Ninth Street
- Turn left onto East Ninth Street and cross Lakeside Avenue
- One Cleveland Center is on the left, and the garage entrances are on St. Clair Avenue (immediately before the building, across the street from The Galleria at Erieview) and Rockwell Avenue (immediately after the building). Additional parking is available at The Galleria at Erieview and the Cathedral Plaza Parking Garage (across from garage entrance on Rockwell).

From the Southeast

- Take I-480 West to I-77 North
- Exit at East Ninth Street
