Overview

Representative Matters

- Devised argument resulting in the staying of hundreds of millions of dollars of contractual payments on a motion for interim relief in an arbitration.
- After a bench trial, obtained sanctions order dismissing claims alleging more than \$280 million in damages where an opposing party fabricated evidence that could have voided the limitation of liability clause.

- Saved a client manufacturer tens of millions of dollars by removing price caps on two preexisting contracts the parties had operated under for years.
- Secured the dismissal with prejudice of class action claims in an off-label marketing case seeking billions of dollars of damages.
- Prepared an out-of-court factual presentation to plaintiffs that convinced them to voluntarily dismiss a client from an eight-figure tort action alleging environmental contamination.
