Overview

He represents clients through all stages of litigation, including trial, *inter partes* review and other PTAB proceedings, and appeals. Charan also leverages his trial experience to advise clients on IP portfolio development, provide pre-litigation and freedom-to-operate opinions, prosecute high-value patents relating to a variety of technologies, and review key assets in transactional due diligence.
