Overview

Deana also has experience in products liability suits, including defending manufacturer of off-road vehicles in personal injury suits involving claims that the products were defectively designed and manufactured, as well as resolving contract disputes between product manufacturers and suppliers. Deana also has experience litigating and arbitrating commercial business disputes involving business dissolution, contract disputes, insurance/reinsurance, commercial landlord-tenant issues, labor and employment, and workers' compensation related disputes.
