Overview

Representative Matters

- Successfully defended Learfield IMG College in federal litigation brought by former Buckeye and NFL commentator Chris Spielman, who asserted a challenge to college-athletics amateurism at The Ohio State University and nationwide.
- Favorably resolved a variety of commercial disputes on behalf of the Cleveland Cavaliers; a fast-growing scrap-metal company; a fiber-optic cable network designer; a software interface designer; and a health-products distributor confronting business misconduct in the face of the pandemic.
