Overview

Nicole is a nationally recognized complex commercial litigator, selected by Chambers USA, with over two decades of experience defending and pursuing high-stakes disputes that shape legal precedent. As a sought-after advocate in “bet-the-company” litigation, she combines deep strategic thinking with practical execution to deliver exceptional results in the most contentious cases.

Currently, she serves as lead counsel for Smartmatic in a \$2+ billion defamation suit against Fox News. Her representation of Smartmatic against other defendants, such as Newsmax and OANN, has secured successful settlements for the company, as well as a recent summary judgment ruling in favor of the company against Mike Lindell and MyPillow.

Nicole has litigated some of the largest and most high-profile cases in U.S. legal history—from landmark defamation disputes and multibillion-dollar securities fraud claims to serving on the trial team in one of the largest auditor liability cases ever tried. Her practice spans the full litigation spectrum, including intimate business disputes, nine-figure commercial battles, and complex MDL proceedings where she served as liaison counsel defending industry-leading companies.

She regularly advises companies on pre-litigation strategies.
