## Overview

In a single year, he successfully obtained partial summary judgement for a voting machine company on a defamation claim against a public figure, defended an information services technology provider in a multi-million dollar arbitration arising out of an alleged breach of contract and warranty, successfully settled a ten-figure supplier agreement breach, and investigated, resolved and remediated the attempted theft of trade secrets by a former employee.

Tim's advocacy extends beyond the courtroom to include pre- and post- litigation counseling and representation to ensure his clients both know and exploit all legal options and arguments available to them. He recognizes that litigation is a stressful process for any client no matter their size, and focuses on ensuring that his clients are consistently supported, aware, informed and educated on their legal rights and options, taking into account their business needs and desires.

A large impact on Tim's approach and understanding of the litigation process derives from his clerkship for the Honorable Judge Joe Billy McDade of the U.S. District Court for the Northern District of Illinois, which he completed in 2011, before beginning his advocacy work. Following his clerkship, Tim honed his skills at Skadden in Chicago before joining Benesch to further expand his practice.

Outside of his active litigation practice, Tim is committed to nurturing new legal talent as co-chair of the Chicago office's Hiring and Litigation Hiring Committees. He also serves as a Board Member and Vice President of Esther's Friends, the Esther Viola Frey Memorial Foundation, which provides critical support to families of children facing long-term hospitalizations in Chicagoland.
