## Representative **Experience**

- ▶ Served as lead counsel for a major life science manufacturer, representing the client in individual investigations and litigation brought by attorneys general in Arkansas, Mississippi, New Mexico and Pennsylvania alleging violation of state false advertising statutes.
- ▶ Represented a medical practice in a Department of Justice federal criminal investigation involving the U.S. Department of Health & Human Services Office of the Inspector General, the United States Postal Service Office of the Inspector General, and the Drug Enforcement Administration, and state investigations involving the Ohio Attorney General Health Care Fraud Unit. A total of 61 expert witnesses offered testimony, including 17 witnesses on behalf of ComEd. The Illinois Commerce Commission approved a \$595 million increase in ComEd's revenue requirement and a \$3.57 billion increase in rate base over the four-year period.
