Regulatory Influence

Our team has strong relationships with regulators and actively shapes the policies that govern the legal cannabis industry.

Representative **Matters**

- ▶ Represented Caliva, a leading California vertically integrated cannabis company, in its combination with Subversive Capital Acquisition Corp. (NEO:Gram.U), the largest cannabis SPAC and largest Canadian SPAC to date.
- ▶ Representing Red Arrow Farm, a Michigan-based cultivation and processing facility that has increasing market share in the still-developing adult-use market in the state, as outside general counsel in matters including regulatory and corporate counsel on an ongoing basis. Red Arrow is a pioneer in a brand-new industry in Michigan and faces myriad legal challenges at the state and local level along the way.
