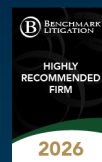

Representative Matters

- ▶ Achieved a significant summary judgment decision for Smartmatic in its defamation case against MyPillow and Mike Lindell. The Court found Lindell's accusations were false and defamatory per se and that MyPillow was vicariously liable for their publication. The ruling also found injunctive relief was appropriate pursuant to the Minnesota Deceptive Trade Practices Act. The case will be proceeding to trial in Minnesota Federal Court in 2026.
- ▶ Defended Commonwealth Edison (ComEd) against multimillion-dollar claims for breach of contract stemming from a series of complex construction contracts. After contentious discovery, the parties proceeded to a bench trial in the Circuit Court of Cook County. The Court held in favor of ComEd and the plaintiff is now appealing the ruling.
- ▶ Defended Feit Electric in six-year-long litigation brought by a multibillion-dollar Japanese LED lighting company claiming patent infringement and seeking tens of millions of dollars. Following a two-week trial, and after just one hour of jury deliberation, Benesch secured a unanimous verdict of no liability.
- ▶ Achieved a resounding pretrial victory for Ohio University in a case stemming from the death of a student at an off-campus property. The family sued the academic institution for negligence, wrongful death, pain and suffering, and damages for allegedly violating an anti-hazing statute. In granting the summary judgment motion to dismiss all claims, the court set new precedent and vindicated the school's efforts to combat hazing and protect students.
- ▶ Represent First Energy in an administrative litigation involving an estimated \$1.4 billion in rate increases. The case was litigated by 26 parties, including advocates for residential customers, business customers, environmentalists, competitive retail suppliers, governmental aggregators, wind energy advocates and others. This case will establish cost recovery for major investments made by our client over the next eight years.
- ▶ Represented Cisco Systems, Inc. in a nine-figure trade secret misappropriation brought by a former supplier prospect. Negotiated a settlement on the eve of trial after a series of successful motions in limine narrowed the scope of the plaintiff's claim. The settlement amounted to less than 1% of the alleged damages.
- ▶ Reached a confidential settlement for Smartmatic in its high-profile defamation suit against Newsmax over the media company's false claims that Smartmatic's voting machines were part of a conspiracy to rig the 2020 election.
- ▶ Achieved a favorable verdict representing Gould Electronics in a billion-dollar federal bench trial regarding a complex environmental case where the government sought remediation costs allegedly arising out of the operation of a secondary smelter (\$136 million in historical expenditures and up to \$700 million in future costs).
- ▶ Represented Professional Bull Riders, Inc. (PBR) in the high-profile bankruptcy trial against television personality Dr. Phil's media company, Merit Street Media (MSM). Following a multiday bench trial, Benesch achieved a complete victory when the court found that MSM's Chapter 11 bankruptcy was improperly orchestrated by Dr. Phil for his personal benefit, that Dr. Phil intentionally destroyed critical evidence, and that MSM's bankruptcy professionals lacked independence and violated their duty of candor to the court. The court converted the case to Chapter 7, ensuring MSM's assets and the interests of all creditors are protected.
- ▶ Obtained a unanimous victory before the Ohio Supreme Court on behalf of three investor-owned utilities, upholding the recovery of \$115 million in prudently incurred costs associated with a coal-fired generation facility.
